

# COVID-19 Family Agreement

Girl Scouts of Southern Nevada is committed to providing a safe environment for girls, volunteers, families, and the greater community. As we begin to resume in-person activities, it is important that we follow national, state, and local guidance to help minimize the spread of COVID-19. **This form is required for EVERY in-person event, activity, or meeting.**

**Prior to participating in any in-person troop or group Girl Scout activities, I agree to:**

**Do a health check and stay home** if my Girl Scout or household members show any of the following symptoms-

- Fever (100 degrees Fahrenheit or above)
- Cough
- Shortness of breath
- Sore throat
- Headache
- Muscle aches
- Loss of smell or taste

**Follow good hygiene practices.**

- Wash hands thoroughly for 20 seconds or use hand sanitizer
- Cover coughs and sneezes with an elbow or tissue and throw away after use

**Use social distancing.**

- Maintain a 6-foot distance from others when possible.
- Refrain from hugs, handshakes, "high-fives", and the friendship squeeze.

**Report COVID-19 positive test results to Girl Scouts of Southern Nevada.** If your Girl Scout receives a positive test result within 14 days of participating in an in-person activity, please report this to Girl Scouts of Southern Nevada at 702-385-3677. Staff will contact the families of anyone who may have been exposed during the activity. All information will remain confidential.

**Wear a face covering or mask.** In accordance with [GSSNV COVID-19 Guidance for Meetings and Activities](#), face coverings are required during Girl Scout meetings and activities whether indoors or outside to protect yourself and others from spreading or contracting COVID-19.

**I understand Girl Scout members are not required to participate in any activity. It is the sole discretion of each individual family and their comfort level with the planned activity. If my Girl Scout will participate in person, we will follow the guidance listed above to the best of our ability.**

The Coronavirus disease of 2019 (COVID-19) is thought to spread mainly from person to person, mainly through respiratory droplets produced when an infected person coughs, sneezes, or talks. These droplets can land in the mouths or noses of people who are nearby or possibly be inhaled into the lungs. Spread is more likely when people are in close contact with one another (within about 6 feet). Because it is a new virus, scientists are learning more each day. Although most people who have COVID-19 have mild symptoms, COVID-19 can also cause severe illness and even death. Some groups, including older adults and people who have certain underlying medical conditions, are at increased risk of severe illness. As with any social activity, participation in Girl Scouts could present the risk of your Girl Scout contracting COVID-19. While the Girl Scouts of Southern Nevada takes every safety and preventative precaution recommended by the Centers for Disease Control and Prevention ("CDC") as well as State and local authorities, Girl Scouts of Southern Nevada can in no way represent, warrant or guarantee that COVID-19 infection will not occur through participation in troop or council programs.
